

**MEMORANDUM OF UNDERSTANDING**  
**between**  
**UNIVERSITY OF RZESZÓW, POLAND**  
**and**  
**HIGHER EDUCATIONAL INSTITUTION**  
**«PODILLIA STATE UNIVERSITY», UKRAINE**

**Preamble**

The University of Rzeszów and Higher Educational Institution «Podillia State University», here in after collectively referred to as the "Parties," hereby enter into this Memorandum of Understanding to establish a framework for academic cooperation aimed at promoting friendship, fostering cultural and educational ties, and facilitating the exchange of ideas, information, and scholarly resources between the respective entities. This partnership will enhance research collaboration, support joint academic programs, and facilitate student and faculty exchanges to enrich the educational experience further. Such cooperation shall be pursued on the principles of reciprocity and mutual benefit, aligned with the current capabilities of the Parties, and subject to applicable laws and regulations governing such collaboration.

**§ 1**

The parties hereby agree to establish a framework for cooperation and enhance the academic and research capabilities of all parties in the following areas of mutual interest:

1. Sharing of academic staff
2. Collaboration among scientific and educational researchers
3. Exchange of educational and science resources
4. Sharing of best practices in academic methods and curriculum organization
5. Exchange of students for educational purposes
6. Implementation of innovative educational practices and distance learning
7. Collaboration on research initiatives and projects

**§ 2**

It is anticipated that actions arising from this Memorandum of Understanding shall be initiated in advance by the relevant institutional units of the Parties in conjunction with the administrative units responsible for coordinating international cooperation. All actions undertaken must conform to the policies and procedures established by each institution. The exchange of research and teaching personnel, as well as students, shall be conducted in accordance with the prevailing regulations of the Parties.

**§ 3**

The specific terms of cooperation shall be outlined in separate agreements, which will be prepared and executed by duly authorized representatives of each Party. Such agreements shall designate the individuals responsible for implementing the cooperation at each institution and outline the specific terms associated with the cooperation.

**§ 4**

Financial obligations related to the implementation of the activities undertaken by the Parties shall be defined in separate, written agreements.

## § 5

This Memorandum of Understanding is effective from the date it is signed by both Parties and remains in effect indefinitely. Each Party has the right to withdraw from this Memorandum by providing three months' written notice. Any modifications to this Memorandum can be made through mutually agreed-upon annexes by both Parties.

## § 6

The Parties mutually agree to the following:

1. This Memorandum of Understanding shall not restrict the ability of participants to engage in similar activities with other institutions, organizations, or individuals, whether public or private.
2. Any amendment to this Memorandum shall be binding upon the Parties only if made in writing and approved by both Parties.
3. Both Parties agree that any activity will be considered voluntary and without financial obligation.

## § 7

This Memorandum of Understanding has been executed in English in two identical counterparts, with each Party retaining one copy. Alternatively, this Memorandum of Understanding may have been executed in Polish and the language of the foreign institution in four equivalent copies, with each Party receiving one original document in each language version. The text in Polish shall be considered authoritative.

## § 8


